Reservation, Deposit, and Usage Regulations**

Both of these forms must be completed, signed, and returned to GCCC at least THIRTY DAYS PRIOR to your arrival at camp. This form is confirmation of any dates set by phone or in person.

There is a \$7 per person per night fee (including adults) for each person in camp. This fee is based upon each NIGHT each person spends at the camp. There will be no charge for children age five and under who are accompanying adults. The person in charge of your group is responsible for keeping account and for providing the full amount of camp fees. Checks should be made out and mailed to **Gulf Coast Christian Youth Camp, P.O. DEPOSIT INFORMATION

A deposit of \$150 for stays of up to three days, or \$250 for four or more days will be required prior to your group's arrival at the camp grounds. This deposit will be non-refundable unless notice is given of your cancellation 30 days before the first day of your reservation. The deposit will be HELD until the completion of your stay at GCCC. Should there be any damage caused, or items lost or misplaced by your group (with the exception of normal wear and tear), funds from this deposit will be withheld in accordance with the amount needed to repair such damage, or replace any such articles. Should there be damage to the property or facility, or any losses which exceed this set deposit, your group will be responsible for the total cost of the damage or loss. If no damage or loss occurs, the total deposit will be refunded by mail. Should you have any questions about the condition of the camp or items missing upon your arrival, please bring them to the attention of the camp manager or one of the Board members immediately. **Deposit checks should be made out and mailed to Gulf Coast Christian Youth Camp, P.O. Pool and Lifeguards

A Certified Lifeguard (current Red Cross Life Saving, WSI, Senior Life Saving, or equivalent) must be provided any time your group uses the pool facilities. According to Texas State Law, one lifeguard must be provided for each 35 swimmers. No lifeguard is provided by GCCC. Each incoming group will be responsible for providing their own lifeguards.
